The Team has been successful in winning new funds from institutional investors and in winning funding bids.


In autumn we had the installation of more solar panels, which will greatly increase our annual electricity generation.



Financial Performance in 2023



2023 was not quite as sunny as 2022.

With our new sites, we expect a lot more electricity next year.



Income up due to energy market prices.


Grants down so expenses down too.

Depreciation and interest payments as expected. A profit of \pounds 19,949 which we will use to pay off our loan, increase reserves, and a community benefit payment which we will consult Members on in due course.

A Huge Thank You to We Have The Power

We were able to place the order and start on site months early – thanks to a bridging loan: So we gratefully acknowledge:

"This project was catalysed by a philanthropic loan from Tim Stumpff and Julia Davies through the <u>We Have The POWER</u> project."



We borrowed £100k for capital. We continued raising capital to year end, and immediately paid £28k back. We will pay the remaining £72k through further share investment, plus some of our own income. The interest rate rises quarterly to the repayment deadline of October 2024. Board were comfortable with plans to repay, but if we can't we have contingency plans.

Thanks to our other funders:

One day, we will have enough renewable energy generation to fund our own project development, but until then we are so grateful to our other funders:



North East Lincolnshire Council – UK Shared Prosperity Fund – supported costs for our office and team, with a contract to deliver renewable energy projects locally, run our share offers and engage lots of people and organisations.

Co-operatives UK Booster Fund – supported us with revenue funding to cover the development of our share offer and getting the Community Shares Standard Mark. Invested £40,000 on the same terms as all other Members.

Northern Powergrid Net Zero Communities Fund – provided revenue funding to support our student placements and promotional activity during the share offer period.

GCE's Board – continuous service plus new faces


All our existing Board Members continue to serve. This year, we have put out a call for two younger directors. Community owned renewable energy is a long-term business and addresses climate change. For both, we believe that involving younger people is essential.

Lay Audit

Last year, AGM voted for an audit. Stuart Greenfield has acted as a lay auditor and been given full access to GCE's records and staff for his investigations. He has written to the Board of GCE with his findings. The Board and the operations team will ensure his recommendations are followed. We thank him very much for his time and effort.



The forecast for 2024 – from the figures we know:



The chart uses figures which we have contracts for, or know from sound solar predictions.

It doesn't include anything we haven't "won yet," nor the next share offer.

So, we expect a small profit in 2024.

Bank balance calculated as always more than £20k which is reviewed at Board.

Community Share Offer #5 in 2024

We are developing an offer to develop solar PV on yet more sites. This would be an Open Offer – so can be used for several years to fund multiple sites.

For starters we will raise capital for:

- A further 100kW at CATCH.
- Any loan not paid back yet to We Have The Power

We are considering potential sites for the "Coming Next" list.

Future Developments

In the last week of the year, we applied to the Community Energy Fund from <u>Midlands Net Zero Hub</u> for a grant of up to £40,000 for a feasibility study on the potential to host wind turbines in the local area.

Board approved doing this as it would balance our income throughout the year if we are receiving income from both solar and wind power. Also, other community organisations have gone this way and we thought that we should too.

We expect to hear back early 2024 and will take advice from suitable consultants and community energy bodies who have experience in this area.
